**ELIGIBILITY:** Open to all fine artists over the age of 17. No agents, dealers or brokers permitted.

**ELIGIBLE MEDIA :** Oils/acrylics, watercolors, pastels, drawings and graphics, woodcarving, pottery (wheel thrown or hand built), and metal working which can be classified as sculpture. All work must be original to the artist. Reproductions of these are allowed.

**NOT ACCEPTABLE MEDIA:** Photographs, jewelry, glass pattern molded ceramics, plastics, Christmas decorations, beadwork, needlework, scissors work, embellished items (barn boards, stones, leather, shells, buttons, shingles, tin), commercial or "found" items decorated with oils or acrylics, reverse painting on glass, tinsel painting, wood burnings, painted tin, theorems, fractur, painted T-shirts or other crafts, computer generated art, furniture. Other items that do not fit into the eligible media criteria listed above.

**WE RESERVE THE RIGHT TO REMOVE UNACCEPTABLE EXHIBITS FROM THE SHOW.**

## ADULT CATEGORIES AND PRIZES:

- Best of Show: \$250
- Oils/Acrylics, Watercolors, Drawing/Graphics: 1st-\$150, 2nd-\$100, 3rd-\$75, 4th-\$50
- Pastels: One prize only of \$150
- Sculpture: One prize only of \$150
- Special Judge's Awards: Five prizes of \$50 each in any medium
- \* Mixed Media: One prize only of \$150

**DISPLAYS:** All paintings, pastels, and drawings must be framed or matted. Artwork must be displayed on panels/easels/tables within the confines of your assigned space(s).

**ENTRY PROCEDURE:** \$70 per 10 foot space. One artist per space. Adjoining spaces available upon request at \$70 each. If you need more than a 10 foot space, please pay for more than one space. Mail attached entry form and entry fee to **Village Art Association, P.O. Box 66, Lititz, Pennsylvania 17543-0066**. Entry fee checks should be made payable to **Village Art Association**. You must include a self addressed stamped envelope for your space assignment. Applications will not be processed until one is received.

**SPACE ASSIGNMENT:** Spaces will be assigned following the May 1<sup>st</sup> deadline. **PLEASE NOTE THAT THIS DEADLINE IS FIRM.** Two artists wishing adjacent spaces must mail BOTH applications together. You will receive a card confirming your show entry and space assignment

**FREE ART SHOW SPACE:** Any Artist interested in being a VAA guest speaker for their 2012 Program should contact Dave Nolt at 717-656-2530. They will be paid \$45 or given a free space at the 2013 Art Show (worth \$70).

**ARRIVAL PROCEDURE:** All artists must enter the park from Route 501 (Broad Street) and proceed to their assigned space(s) which will be given to you on your entry acknowledgement card. Under no circumstances may artists park in the grassy area to unload. Any artists parking in the grassy area will not be invited back to next year's show. Artists must check in at the headquarters table in the park prior to 9:00 am to confirm your attendance. **SPACE NUMBERS MUST BE DISPLAYED FOR JUDGING PURPOSES. PLEASE NOTE: Spaces will be sprayed by 5pm on July 27, 2012. You may set up after this time, but early set up is done at your own risk!**

**JUDGING:** Judging will take place from 9:00 am to 1:30 pm. You will receive three stickers with your confirmation card. Use them to designate which works you wish to enter in the judging. Only those three pieces will be considered for prizes. **Only originals and pieces that have not received an award in any previous VAA show are eligible for prizes.** Judges for this year's show will be announced at a later date.

**RESPONSIBILITY:** Each artist will assume responsibility for his or her entry. Sponsors will not be responsible for loss or damage to any work of art exhibited. Each artist is responsible for art exhibited. Each artist is responsible for collecting tax on their own sales. All work is subject to these conditions. No commissions are taken on sales.

**UPCOMING SHOW:** The Lititz Outdoor Art Show is always held the last Saturday in July. Mark your calendar for next year and tell your artist friends about this great opportunity for exhibiting
